

Guidelines for ASW Host Families and Student Guests

THANK YOU FOR HOSTING

Many students have never stayed in another person's home or traveled from country to country before. Your contact with them will make them feel welcome and relieve any anxieties they may have. You should make personal contact with your guest(s) as soon as possible after their arrival at the school. The opportunity to share a home environment will make their stay in Warsaw a special event.

HOSTING GUIDELINES

- 1. Make arrangements for transportation, meals and after event plans with student guests.
- 2. ASW Host families are responsible for picking up student guest(s) up at the school on their arrival, and returning them to the school when they depart.
- You also will bring them to and from the school during the event. ASW will take care of student transport to the Warsaw International Airport, or TheTrain Station.
- 4. Students have been informed of the 22:00 curfew. Coaches may call host families to check on student guests. Please make sure that guests are in your home by the curfew time.
- Student guests are in care of host families unless there is an emergency. In the case of an emergency, please contact the tournament director and/or the coach of the student involved, These emergency numbers are listed at the bottom of the page,
- 6. With regard to going out during the evening, host families should exercise good judgment. It is not appropriate for guests to go to nightclubs or bars. Be certain the guest has your name, address, and telephone number with him or her at all times.
- 7. Please discuss taking precautions when your guests are out and about in Warsaw:
 - Be aware of their surroundings.
 - Never travel alone always travel with a minimum of three people in a group.
 - o Do not loiter outside in public areas.
 - Avoid confrontation with potential aggressors
- 8. Middle Students need to be in the company of an adult at all times.

Governing Association, Rules and Regulations

These bodies provide the structure and oversight for interscholastic competitions among International Schools.

ASW adheres to the following guidelines listed below for hosting incoming students. Parents and students should know and discuss the Guidelines for Parents and the regulations for students. They are in effect for you and your guest(s) from the time they arrive at ASW until departure.

STUDENT RULES AND REGULATIONS

- Students shall obey all instructions given them by their host parents and their advisors as if their own parents gave these instructions to them. This applies to all activities irrespective of location undertaken during the period of the tournament or competition.
- 2. Smoking, any other use of tobacco, the drinking of alcohol and the use of drugs are not permitted.
- 3. Housing arrangements made by the responsible official of the host school may not be changed.
- 4. The curfew for this event is 22:00. All tournament student participants must be in the host family home by this time.
- Neither host families nor students may negotiate changes to regulations for students with respect to curfew, housing arrangements, the use of tobacco, alcohol or drugs or any other rules or provisions set forth by the host school.
- 6. These regulations apply to all students for the entire tournament and also during the journey to and from the site of the event. This includes students from the host school, visiting students, and other students visiting throughout the event's duration.
- 7. All laws of the country must be observed.
- 8. Any problems should be reported immediately to the host school for corrective measures.

Violation of these regulations could result in dismissal from the remainder of the tournament, immediate transport home at the parent's expense, and will be reported to the student's home school administration for further action.
